## <u>Unemployment</u>

If you are unemployed, apply for benefits at unemployment.ohio.gov or call (877) 644-6562.

Unemployment benefits will also be available for eligible individuals who are requested by a medical professional, local health authority, or employer to be isolated or quarantined as a consequence of COVID-19, even if they are not actually diagnosed with COVID-19. In addition, the waiting period for eligible Ohioans to receive unemployment benefits will be waived.

#### **Internet Access**

Spectrum is offering free broadband and Wi-Fi access for 60 days to households with K-12 and/or college students who do not already have a Spectrum broadband subscription and at any service level up to 100 Mbps. To enroll, call 1 (844) 488-8395. Installation fees will be waived for new student households.

## **Legal Aid**

The Legal Aid Society of Cleveland will continue to serve clients during the COVID-19 pandemic. In this time of uncertainty, people will have legal needs related to shelter, safety and economic security – and Legal Aid remains committed to meeting those needs.
